POLICIES OF FAIRHAVEN SHIPYARD COMPANIES INC.

1. All customers must provide an authorized contact name, phone number, valid street address, and vessel I.D. number or documentation number for billing information.
2. All vessels that are not being actively worked on by Fairhaven Shipyard Companies and that are not in active storage contracts with Fairhaven Shipyard Companies are subject to a charge of \$1.00 per foot per day surcharge.
3. As a health and safety precaution, customers and vendors are asked to limit smoking to authorized areas only. Smoking is not allowed in any buildings at any time.
4. All outside contractors must show proof of liability and worker's compensation insurance and must contract through a Fairhaven Shipyard Company purchase order if working on the property unless specific prior approval has been given by Fairhaven Shipyard Companies management.
5. All boats brought to Fairhaven Shipyard must have and, if requested, show proof of active liability insurance in place throughout their stay.
6. Customers and their vendors are expected to help us maintain a safe and clean environment. If we determine that clean-up is necessary due to our customers or vendors, a clean-up charge will be assessed to that boat.
7. All rates as noted are subject to a 6.25% Massachusetts sales tax , 2% Environmental Surcharge and 2% Misc supply charge where applicable..
8. Fairhaven Shipyard Companies, Inc. is not responsible for theft or any damages due to fire, wind, or any acts of nature while a customer's boat is on Fairhaven Shipyard Companies property.

PAYMENT AND BILLING TERMS

1. All customers that are having extended work done at the shipyard will be billed on a weekly basis.
2. Forms of payment are check, money order, cash, wire transfer, Visa, MasterCard, and Discover. 3. Before any vessel leaves Fairhaven Shipyard Companies, the full balance of the bill is expected to be paid.
